

STATEMENT OF GOALS AND PURPOSE

The purpose of FreeSchools World Literacy is to provide free education in order to break the cycle of ignorance and poverty that leaves millions in hopeless despair. The organization provides free literacy programs; teacher employment and training; income-producing skills, health education; food and clothing; and is documenting changes in the wellbeing of the community as a result of its programs. By providing ongoing funds and scholarships for the existing and planned new schools, FreeSchools World Literacy hopes to replicate its model throughout India and other developing countries of the world.

FreeSchools World Literacy Objectives are as follows:

1. To provide literacy programs and classes to members of the public.

2. To develop and provide education and training programs to persons who will conduct literacy training.

3. To develop employment training and education programs for needy persons.

4. To relieve poverty in developing nations by providing food and other basic supplies to persons in need.

5. To develop or promote public health in developing nations by educating and instructing the public on prevention of and curative measures for, health problems and by researching and documenting changes in the health of the community

PROGRAM ACTIVITIES

President's Report

It has been nearly two decades now since Mark Bloomfield and I traveled to Motihari Evening School in Bihar State, India in 2000 – a single schoolhouse for the poor children of the village being run by Sister Crescence. There, I realized for the first time in my life, the real need for free education for the poor, and the ability of education to drastically change the lives of those who were lucky enough to get it. I also saw the benefits of that knowledge spread from the student back to their families and to the local community.

Since that time, donors in Australia have raised a total of \$90,000 towards our educational efforts.

This year we have achieved a significant milestone in our work in both Thailand and Zambia:-

1. In Thailand, the program that FreeSchools World Literacy has maintained and improved over the past nine years, will now run without our help under the supervision of the Mirror Foundation. The Thai government continues playing its part - taking on funding of those schools that demonstrate their importance to the local community by having maintained full enrollment for a period of 3 years.

2. In Zambia, Immanuel Mercy's Kantalomba School is now self-sufficient. The Zambian government will manage the teacher's salary costs previously covered by FreeSchools World Literacy. We acknowledge Committee Member, Donna Cervantes, for her single-handed support of the project, and echo the sentiments of Raymond Hockley of Swan Christian College, Perth, "…my heartfelt gratitude on behalf of myself and the people of Kantolomba for Donna's support over all these years. We have been fortunate to have the faithful support of Donna to cover this teacher's salary up until this time where the government is prepared to step in. Thank you again and may the Lord Jesus bless you in all that you do." On behalf of the FreeSchools Committee of Management, I again congratulate Donna on achieving this important milestone.

We have done our job; FreeSchools has completed its mission in Thailand and Zambia. We are now able to turn our resources to the Indian schools and the great need of the children there through the selfless work of our field partner; Sister Crescence and the Fakirana Sisters Society in Bihar State, India; where we are seeing the real benefits of this education flow back into the local community.

In Bihar State, we have 980 students being taught by 27 teachers at 23 FreeSchools World Literacy funded centres.

A total of \$5,226 was raised for FreeSchools World Literacy aid projects during the 2017 reporting period for the Free Schools in Bihar, India, thanks to the fundraising efforts of a dedicated group of regular donors including Isabel Abraham, Melissa Alldis, Donna Cervantes, Catherine Hoffmann, Marion Lesaffre, Bob Mills, Che Stapleton, Kathleen & Trevor Swadling, Andrew & Delphine Swadling, Ken Morley, the Coenraads Family's Francis C. Nieves Memorial Fund, the Forest Kirk Women's Fellowship This also includes student scholarships raised by the Forest Kirk KidzChurch (for Shilpi), Warrick & Lorna Brady (for Lalmuni), the Forest Kirk Men's Group (for Subhash) and Francheska Coenraads (for Ruby). (FreeSchools World Literacy annual registration fees of \$55.80 were donated and paid directly by Secretary Ian Esmore).

FreeSchools World Literacy maintains high-quality audited annual accounts and reportage presented to Australian Council for International Development (ACFID) standard.

Finally, I would especially like to thank the FreeSchools World Literacy Committee of Management, many of whom have been members and donors since the Committee's inception.



Statement:

1. FreeSchools World Literacy is reliant on donations for its overseas projects and is financially healthy. During 2017 FreeSchools raised \$5,226, bringing its bank balance to a total of \$5,375. On Jan 7, 2018 FreeSchools sent \$5,370 to its India Project. Bank costs of \$20 will be incurred in sending these funds overseas and seen in the 2018 accounts.

2. These funds were disbursed in their entirety to FreeSchools project in Bihar, India (\$5,370) where they were used to pay salaries of teachers working at the FreeSchools. This works out to be an average cost of about \$15 to \$20 per year per child being educated and we consider this application of donor funds to be highly effective in providing an education to disadvantaged children.

3. The Thailand and Zambia projects were closed off during 2017 due to our objectives having been met,

4. Although currently not a financial member of ACFID, FreeSchools World Literacy remains fully committed to full adherence to the ACFID Code of Conduct.

Audit Report for the year ending 31 December 2017

Following an audit of the above organization, it is my opinion that the financial records and supporting statements give a true and fair view of the activities of this organization for the year indicated above.

It is noted that as in past years no official receipts were issued for each donation, but it is understood each donation was acknowledged by letter and each donation can be traced as a separate entry on the bank statements. This is considered to be satisfactory at present. If the committee for the FreeSchools World Literacy were to consider issuing official receipts at some future time, then that would be an additional safeguard to the present system of acknowledgement by letter of each donation.

In accordance with the ACFID Code of Conduct a Table of Cash Movements for Designated Purposes has been included in the Financial Reports for the year ended 31 December 2017 and has been noted and verified by the auditor.
