



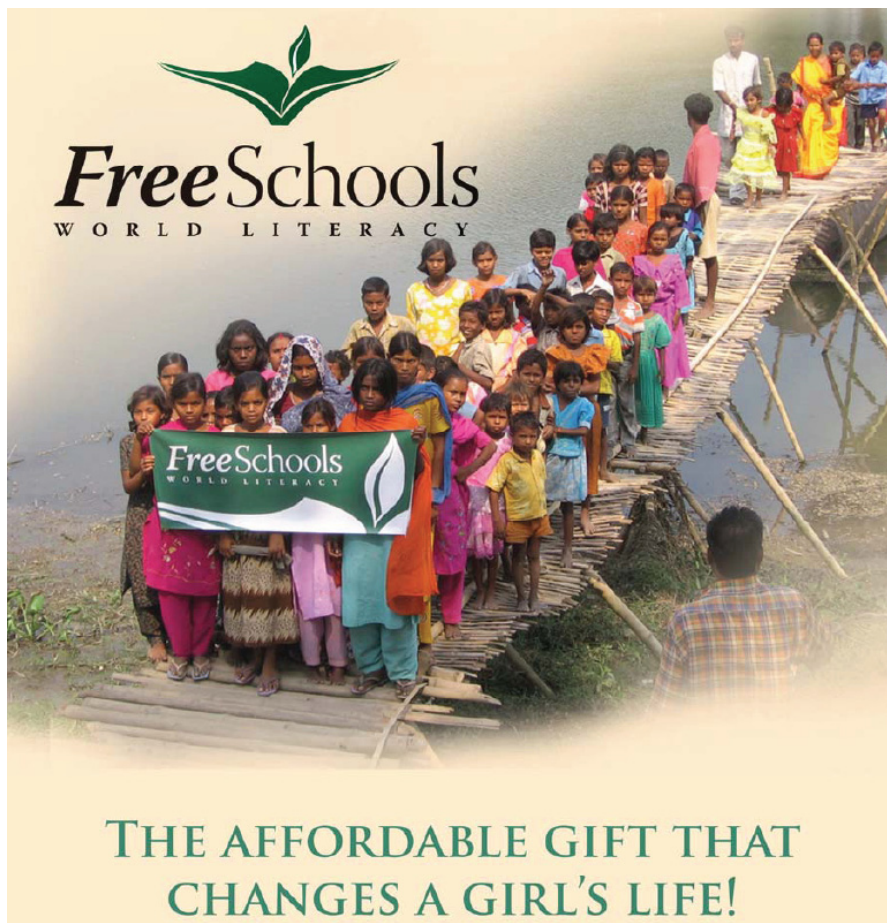

STATEMENT OF GOALS AND PURPOSE

The purpose of FreeSchools World Literacy is to provide free education in order to break the cycle of ignorance and poverty that leaves millions in hopeless despair. The organization provides free literacy programs; teacher employment and training; income-producing skills, health education; food and clothing; and is documenting changes in the wellbeing of the community as a result of its programs. By providing ongoing funds and scholarships for the existing and planned new schools, FreeSchools World Literacy hopes to replicate its model throughout India and other developing countries of the world.

FreeSchools World Literacy Objectives are as follows:

1. To provide literacy programs and classes to members of the public.
2. To develop and provide education and training programs to persons who will conduct literacy training.
3. To develop employment training and education programs for needy persons.
4. To relieve poverty in developing nations by providing food and other basic supplies to persons in need.
5. To develop or promote public health in developing nations by educating and instructing the public on prevention of and curative measures for, health problems and by researching and documenting changes in the health of the community

PROGRAM ACTIVITIES

President's Report

It has been nearly two decades now since Mark Bloomfield and I traveled to Motihari Evening School in Bihar State, India in 2000 – a single schoolhouse for the poor children of the village being run by Sister Crescence. There, I realized for the first time in my life, the real need for free education for the poor, and the ability of education to drastically change the lives of those who were lucky enough to get it. I also saw the benefits of that knowledge spread from the student back to their families and to the local community.

Since that time, donors in Australia have raised a total of \$93,683 towards our educational efforts.

In Bihar State, we have 980 students being taught by 27 teachers at 23 FreeSchools World Literacy funded centres.

A total of \$3,923 was raised for FreeSchools World Literacy aid projects during the 2018 reporting period for the Free Schools in Bihar, India, thanks to the fundraising efforts of a dedicated group of regular donors including Isabel Abraham, Melissa Aldis, Donna Cervantes (donated \$500 via FSWL-USA), Alice Chan, Marion Lesaffre, Julian McGarry, Bob Mills, Ken Morley, Saskia Raevouri, Che Stapleton, Kathleen & Trevor Swadling, Andrew & Delphine Swadling, Ken Morley, the Coenraads Family's Francis C. Nieves Memorial Fund, the Forest Kirk Women's Fellowship. This also includes student scholarships raised by the Forest Kirk KidzChurch (for Shilpi), Warrick & Lorna Brady (for Lalmuni), the Forest Kirk Men's Group (for Subhash) and Francheska Coenraads (for Ruby). (FreeSchools World Literacy annual registration fees of \$55.80 were donated and paid directly by Secretary Ian Esmore).

FreeSchools World Literacy maintains high-quality audited annual accounts and reportage presented to Australian Council for International Development (ACFID) standard.

Finally, I would especially like to thank the FreeSchools World Literacy Committee of Management, many of whom have been members and donors since the Committee's inception.

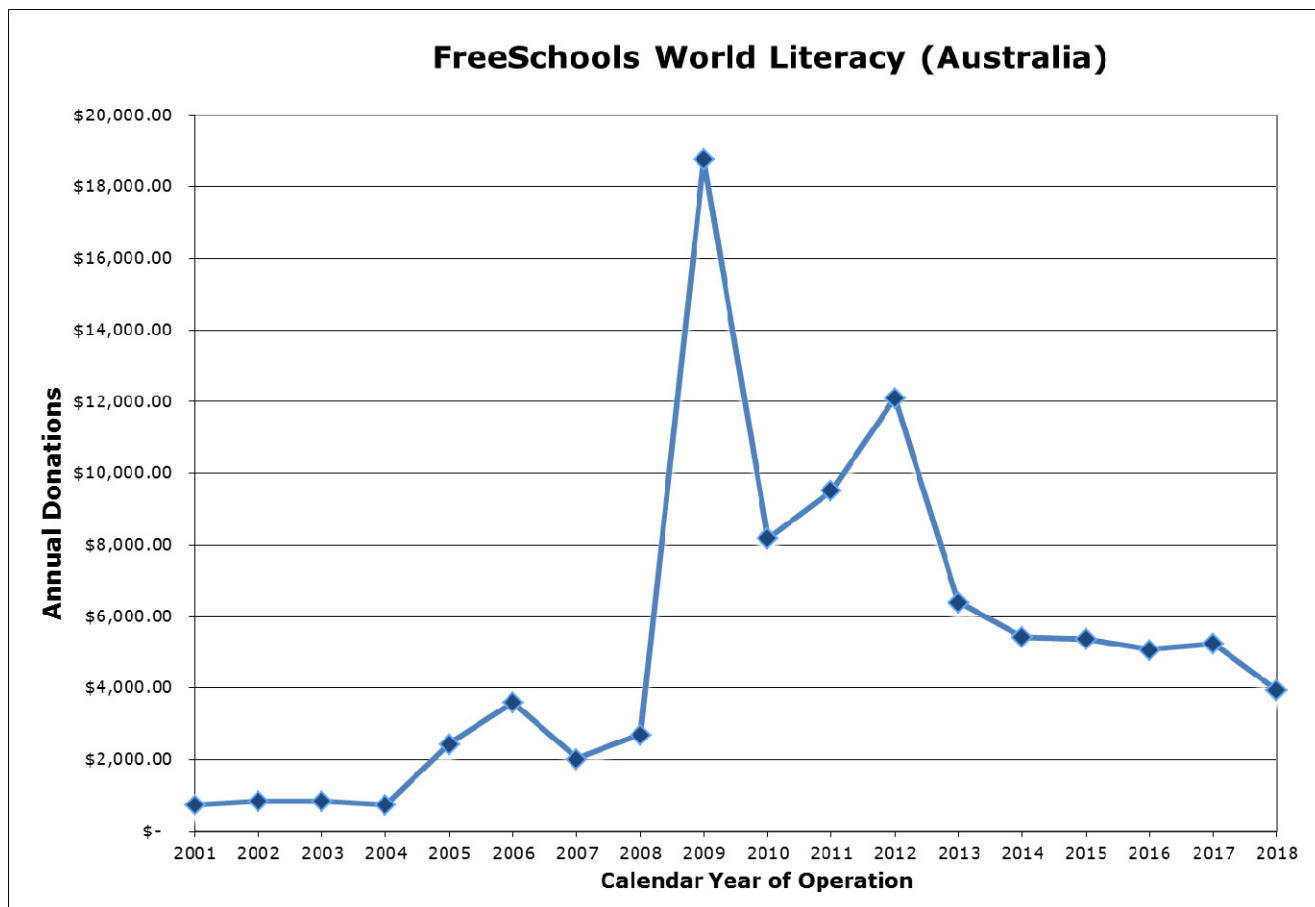

Statement:

- FreeSchools World Literacy is reliant on donations for its overseas projects and is financially healthy. During 2018 FreeSchools raised \$3,923, bringing its bank balance to a total of \$3,918. On Jan 16, 2019 FreeSchools sent \$3,918 to its India Project. Donna Cervantes donation (\$500) is not recorded in our accounts as this was sent directly to FreeSchools USA. No bank costs were incurred in this transfer as the funds were sent via Western Union (at a better rate than the bank and with no transfer fees)).
- These funds were disbursed in their entirety to FreeSchools project in Bihar, India (\$3,918) where they were used to pay salaries of teachers working at the FreeSchools according to the disbursement letter. This works out to be an average cost of about \$15 to \$20 per year per child being educated and we consider this application of donor funds to be highly effective in providing an education to disadvantaged children.
- The Thailand and Zambia projects were closed off during 2017 due to our objectives having been met,
- Although currently not a financial member of ACFID, FreeSchools World Literacy remains fully committed to full adherence to the ACFID Code of Conduct.

Re: Disbursement of Funds

On the 31st December, the Fakirana Sister's Society received Rs. 73255.49 (Au\$1,500) and on the 25th January 2018, a further Rs. 121454.66 (Au\$2417.25) from FreeSchools World Literacy Australia. That is a total of Rs.194710.15 (Au\$3,917.25). This donation is to be distributed as follows.

- 164,710 INR for the FreeSchools World Literacy Program
- 8,400 INR for the Scholarship of Subbhash (700 x 12)
- 7,200 INR for the Scholarship of Shilpi (600 x 12)
- 7,200 INR to the Scholarship of Rubi (600 x 12)
- 7,200 INR to the Scholarship of Lalmuni (600 x 12)
