Personal information collection

Using personal information

FreeSchools World Literacy may only use your personal information for:

2. To collect further donations from you only as per your instructions.

Where FreeSchools World Literacy discloses your personal information to its in-country partners for these purposes, the in-country partner in question will be obligated to use that personal information in accordance with the terms of this privacy statement.

In addition to the disclosures reasonably necessary for the purposes identified elsewhere above, FreeSchools World Literacy may disclose your personal information to the extent that it is required to do so by law, in connection with any legal proceedings or prospective legal proceedings, and in order to establish, exercise or defend its legal rights.

Securing your data

FreeSchools World Literacy will take reasonable technical and organizational precautions to prevent the loss, misuse or alteration of your personal information.

FreeSchools World Literacy will store all the personal information you provide on its secure servers.

Cross-border data transfers

Information that FreeSchools World Literacy collects will be stored and processed in Australia, but may be transferred between any of the countries in which FreeSchools World Literacy operates to enable the use of the information in accordance with this privacy policy.
